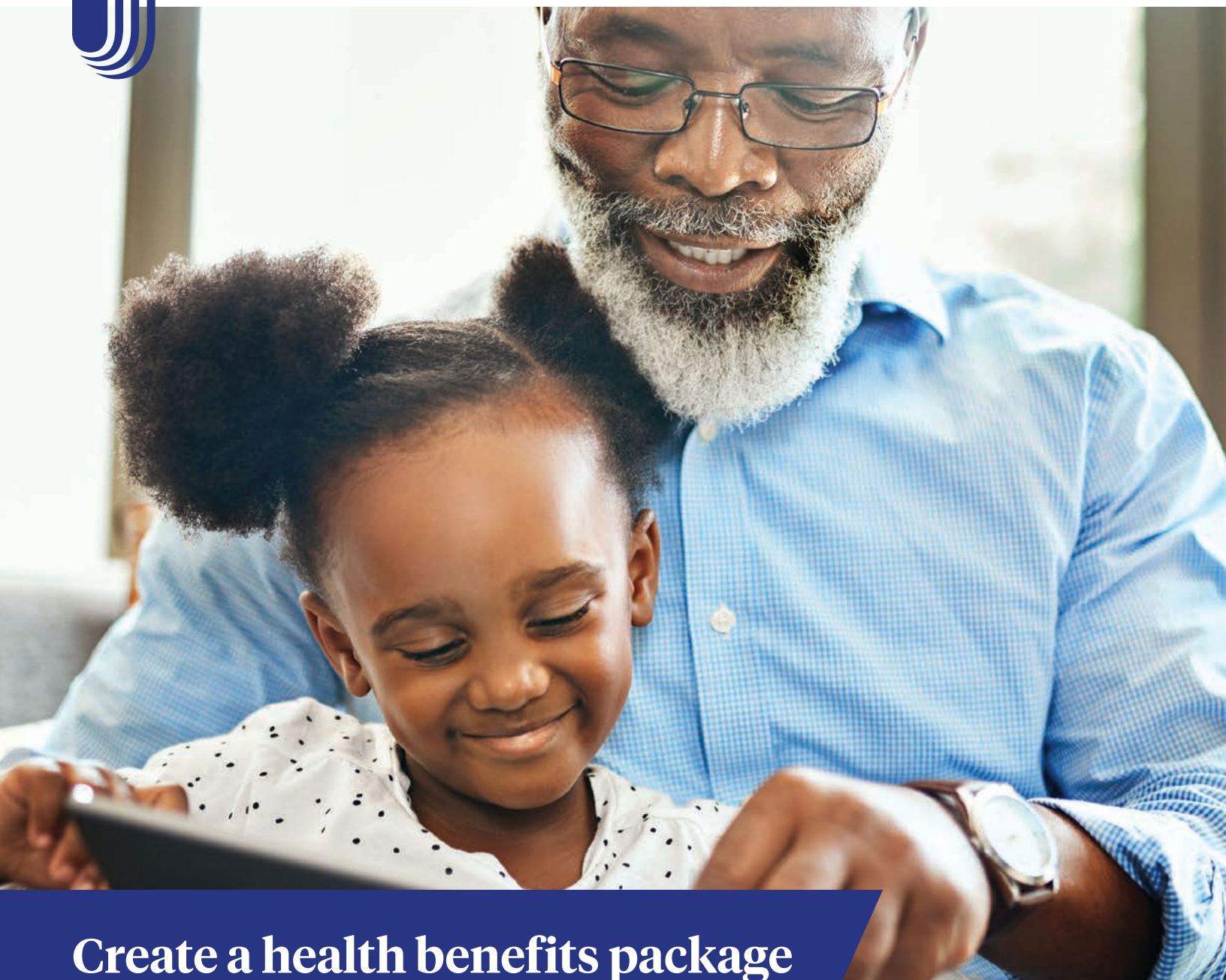

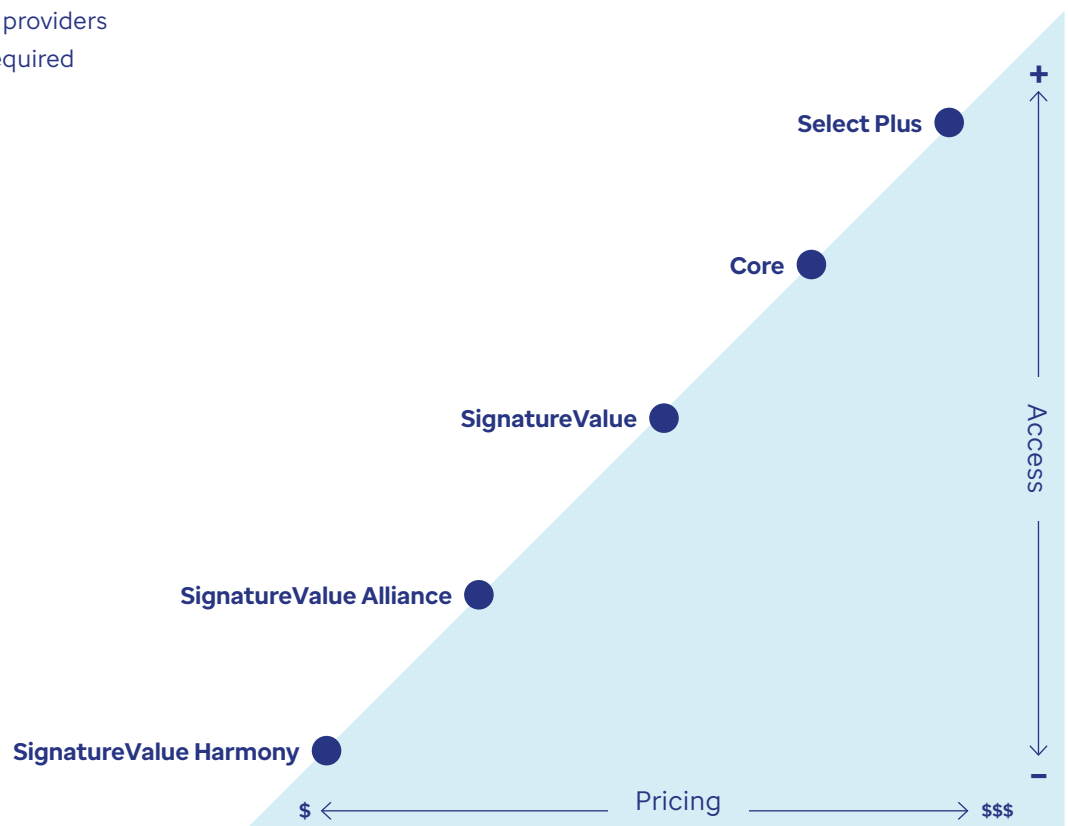

New funds are reloaded each year, and employees may roll over remaining card balances each plan year up to \$2,000. Care Cash is only available with select plans, and program availability excludes health account deposits (HRA, HSA).
