- Complete submission documents
 - Employer Application for Insurance Coverage
 - Employee Enrollment Census Template (T401-41)
 - Enrollment Acknowledgement Form (1133-4)

Remember if groups prefer to be underwritten via IMQs, we can still accommodate. Alternatively, groups with 100 or more enrolled employees can opt to use experience underwriting.
