¹¹Procedures consistent with established medical practices in the treatment of infertility are covered when authorized by the member's Primary Care Physician, including diagnosis, diagnostic tests, medication and surgery. Gamete Intrafallopian Transfer (GIFT) services are covered when authorized by UnitedHealthcare's medical Director. GIFT benefits are limited to three (3) cycles during a member's lifetime when Medically Necessary. A cycle is defined as drug-induced ovulation and monitoring of hormonal levels with or without ova retrieval. Infertility is defined as either: (1) the presence of a demonstrated condition recognized by a participating Medical Group as a cause of infertility, or (2) the inability to conceive a pregnancy or to carry a pregnancy to a live birth after a year or more of regular sexual relations without contraception.
